ORDER:

In the circumstances stated by the Director, Welfare of Disabled and Senior Citizens, Hyderabad in the reference 6th read above, Government after careful examination hereby issue the following amendment to the guidelines issued in G.O.Ms.No.17, Department for Women, Children, Disabled & Senior Citizens (Sch.II) dt:01.10.2020

Existing Provision in the Guidelines	Amendment to Guidelines
1. Para-6 Service Area Credit Plan of Annexure-I: The budget allocated under this scheme has to be distributed among all the districts basing on the PwD population in the District. The Director, WD&SC shall allocate the subsidy amount to (33) districts taking the District wise population into criteria as per SADAREM data. The DWOs of all the Districts and the Asst. Director, WD&SC, Hyderabad District shall prepare the Dist. Annual Action Plan and indicate in the Service Area Credit Plan with the approval of the District Collector & Chairman, Dist. Consultative Committee of Bankers	Para-6 Service Area Credit Plan of Annexure-I: The budget allocated under this scheme has to be distributed among all the districts basing on the PwD population in the District. The Director, WD&SC shall allocate the subsidy amount to (33) districts taking the District wise population into criteria as per SADAREM data. In respect of Rs.50,000/- units Government is allocating (1) unit for each mandal and municipality. The remaining bank linked units allotted for the districts is to be sanctioned by the District Collector based on the District Action Plan prepared in consultation with bankers and other stake holders. The State Government fix the district level targets. The District Collector will have discretion to arrive at intra-district distribution of the units with respect to bank linked scheme.

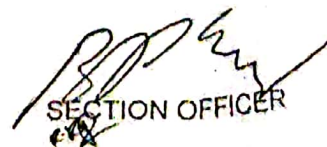
